#### **INTRODUCTION**

## **Abstract of the Report**

In this report on the mapping of the current situation in multiculturalism in adult education in Lithuania, we are presenting our findings of the theoretical and the practical research. In the first part, Findings of the Theoretical Research, we have collected and compiled useful information about multiculturalism in Lithuanian formal and non-formal adult education, in Lithuanian laws and practice. There is a good collection of links to Lithuanian organizations and national and international projects. In the second part, Findings of the Practical Research, you will find summaries of the interviews we conducted with 10 Lithuanian and 1 American adult educator working with Lithuanian and multicultural adult learners, and with 2 adult learners who have come from abroad to study in Lithuania. And finally, you will find information on the five biggest ethnic groups living in Lithuania and everything you need to know about them – values, rituals, attitudes, and more.

#### 2. The current situation on the National Policies and Strategies to support multiculturalism.

#### 2.1 The existent national policies and strategies

Since the re-establishment of independence in 1990, Lithuania has carried out policies of promoting ethnic majority groups' cultural identity, especially focusing on inherited cultural traditions and Lithuanian language as a state language. The Constitution of 1992 contains articles that clearly mention the rights of ethnic minorities and prohibit discriminating or granting any privileges based on ethnic background, origin, race, sex, social status, religion, language, convictions, or opinion. Citizens of Lithuania belonging to ethnic communities have the right to foster their language, culture and customs. Ethnic communities have the right to independently handle the affairs of their ethnic culture, organizations, education, charity, and mutual assistance. The state is bound by the Constitution to support national minorities.

These are the main laws that regulate the status of ethnic minorities: the Law on Ethnic Minorities, the Law on the Official Language of the Republic of Lithuania, the Law on Education, the Law on Non-Governmental Organizations, the Law on Citizenship, the Law on Public Information, the Law on Religious Communities and the Law on Political Parties and Organizations. <a href="http://ces.lt/en/wp-content/uploads/2012/03/EtSt Kasatkina Beresneviciute 2010.pdf">http://ces.lt/en/wp-content/uploads/2012/03/EtSt Kasatkina Beresneviciute 2010.pdf</a>

The coordination of the implementation of Lithuanian State policy in the field of national minorities is one of the objectives of the Ministry of Culture, as indicated in the Regulations of the Ministry of Culture of the Republic of Lithuania. With this goal in mind, the Ministry of Culture prepares Government resolutions, drafts of laws, and other legal acts. It also coordinates the drafting and implementation of long-term programs which aim to assist national minorities to keep and protect their culture and identity. The rights of people belonging to national minorities are regulated by the Constitution of the Republic of Lithuania, articles 37 and 45. #### 2.2 The alignment of national policies at the European level

Protecting the rights and freedoms of national minorities and the people belonging to them is an important part of international protection of human rights, which falls within the framework of international cooperation. The Republic of Lithuania has ratified key international agreements which regulate national minority rights.

Ratified agreements of the United Nations:

- The Universal Declaration of Human Rights;
- The International Covenant on Civil and Political Rights;
- The Convention on the Elimination of All Forms of Racial Discrimination;
- The Convention on the Elimination of All Forms of Discrimination against Women;
- The Convention on the Rights of the Child.

Ratified conventions of the Council of Europe:

- The Convention for the Protection of Human Rights and Fundamental Freedoms;
- The Republic of Lithuania signed the Framework Convention for the Protection of National Minorities of the Council of Europe on 1 February 1995, followed by its ratification without any reservations on 17 February 2000.



Lithuanian ethnic communities enjoy broad legislative rights and freedom in the use of their mother tongue, education, culture, including these: they can establish and maintain their own organizations, cooperate with compatriots living in other countries, preserve the cultural heritage of their country, participate in educational activities and disseminate knowledge in their mother tongue. Lithuania was one of the first countries in Europe to sign the Convention for the Protection of National Minorities, which expressed the European Council's and its member states' concern about the risk of ethnic minority existence. The basic principles that guide the country by creating and implementing ethnic policies – development of democracy, prevention of exclusion, unity and the dialogue with various ethnic groups and individuals. The coexistence of countries of the European Union is based on common reference values of Western civilization such as democracy, tolerance, individuality. Tolerance for multiculturalism and its growth should be included in any EU state's policy and appropriate management steps should be taken. Hence, one Lithuania's priority tasks in controlling this process is to deepen the understanding and trust as well as to establish ongoing dialogue between Lithuanian and Lithuanian ethnic minorities, new immigrants, tourists, and others.

#### 3. The current situation in the matter of multiculturalism in adult education at national level.

#### 3.1 In the formal education

Adults in Lithuania may follow formal education programs in different types of institutions, including general education schools, adult education centers, vocational education and training schools, colleges, and universities. The part of the structured system of Adult Education is vocational instruction on the job market. One more part of the formal adult education system is the labor market vocational training. #### 3.2 In the non-formal education

Non-formal adult education can be provided by different organizations, including adult education centers, high schools, qualification-upgrading colleges, private companies, non-governmental organizations or private individuals. Adult learning can be organized by employers and the learning itself can take place in the workplace. According to the Register of Education and Science Institutions, 105 non-formal adult education schools have been registered in Lithuania.



Established in 1992, the Lithuanian Association of Adult Education (LAAE), in partnership with Lithuanian and international adult educators and organizations, facilitates an approach to lifelong learning among the general population and the creation of continuing education opportunities. The LAAE aims to build a network of co-operating adult education organizations, as well as share knowledge and programs.

The Third Age University, which has branches in many towns throughout the country, organizes non-formal education of senior citizens. This public organization's efforts contribute to the integration of citizens of various age groups into society and seek to meet their needs for continuing education.

Non-formal education is also be implemented by institutions providing formal education – vocational training institutions, enterprises which have included such activities in their regulations or have licenses issued by the Ministry of Education, Science and Sport to teach.

Other ministries of the country, such as National Defense, Foreign Affairs, Finance, Transport, Health, Culture, have established their own non-formal adult learning structures where specialists in those fields improve their qualifications.

There are some non-formal education sector courses for adult learners about ICC in Lithuania. For example, the following company is offering quite a few ICC-related courses to the public as well as public servants and business people. Here is some information about the course:

In addition to religious holidays, Lithuanians celebrate: <i>Uzgavenes</i> , which is a carnival celebration, taking place in early February; <i>Kaziukas Fair</i> — an enormous craft fair, taking place on the weekend nearest to St. Casimir's Day in Vilnius and other towns; Mother's Day (on the first Sunday in May) and Father's Day (on the first Sunday in June); Statehood Day (July 6), marking the crowning of King Mindaugas in the 13th century as a Lithuanian king; Lithuanian Song Festival — a massive song and dance festival taking place for more than a hundred years in the summer every 4 years, when thousands of Lithuanian expats with their folk dance and song groups come back to their homeland to participate in the performances and festivities; <i>Saint Jonas' Festival</i> , also known as <i>Rasa</i> (Dew Holiday), <i>Jonines</i> , <i>Midsummer Day</i> or <i>Saint John's Day</i> — a midsummer folk festival celebrated on June 24 all around Lithuania; also newer festivals: <i>Culture Night</i> , happening annually in June or July and presenting up to a hundred and fifty projects by more than one hundred cultural organizations and about 500 artists; <i>Street Music Day</i> — when professional musicians and amateurs come out to perform in the streets, courtyards, and squares, happening in May; <i>The Sea Festival</i> in Klaipeda, held annually since 1934, attracts hundreds of thousands of visitors and offers a wide variety of fairs, concerts, and other events.
Open vs Closed society	Lithuanians have always been known to be very tolerant and accepting of other cultures and ethnicities. In the times of the Great Duchy of Lithuania, in the late 14th century, Grand Duke Vytautas the Great invited and brought to Vilnius families of the Karaites and Tatars as soldiers, and Italians, Jews, and other peoples from all over Europe as business developers. Lithuanians have lived in peace with
